#### **Qualifications and Experience**

The required minimum qualifications for the post of Assistant Professor in Arts, Commerce, Humanities, Education, Law, Social Sciences, Sciences, Languages, Library Science, Physical Education and Journalism & Mass Communication:-

- 1) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in the relevant or as subject equivalent degree from an Indian /foreign university.
- 2) Besides fulfilling the above qualifications, the candidates must have cleared the National Eligibility Test (NET) conducted by the UGC / CSIR, or a similar test accredited by the UGC, like SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standard and Procedure for Award of M.Phil./ Ph.D Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case, may be exempted from NET/SET:

Provided further, candidates registered for the Ph.D. programme prior to July, 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the recruitment requirements of NET/SET for and appointment of Assistant Professor or equivalent positions.

#### Note:

 NET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SET is not conducted. However, Ph.D. degree shall remain the minimum eligibility for appointment of Assistant Professor in such disciplines as per UGC Regulation 2018.

#### **Minimum Qualification for the post of Librarian**

- 1) A Master's degree in Library Science, Information Science or Documentation Science or an equivalent professional degree, with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).
- 2) A consistently good academic record, with knowledge of computerization of a library.
- Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR, or a similar test accredited by the UGC, like SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be.

Provided that, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / Bye-laws / Regulations of the Institutions awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/ SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities /Colleges/ Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in regular mode only;
- b) The Ph.D. thesis has been evaluated by at least two examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The candidate has published two research papers from his/her Ph.D. work, out of which at least one is in refereed journal; and
- e) The candidate has presented at least two papers, based on his/her Ph.D. work in conference/seminars, sponsored/funded/supported by the UGC/CSIR or any similar agency.

#### <u>Minimum Qualification for the post of Assistant Professor (Management)</u>:- (AICTE)

Bachelor's degree in any discipline and Masters Degree in Business Administration / PGDM/ C.A./ICWA/M.Com with first class or equivalent and two years of profession experience after acquiring the degree of Master's degree.

#### **Relaxation in Qualification:**

- i) A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Castes/Scheduled Tribes/ Other Backward Classes (OBC) (Non-creamy layer)/ Differently-abled ((a) Blindness and low vision; (b) Deaf and hard of hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attact victims and muscular dystrophy; (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace mark procedures.
- ii) A relaxation of 5% may be provided, (from 55% to 50% of the marks) to the Ph.D. degree holders who have obtained their Master's degree prior to 19<sup>th</sup> September, 1991.
- iii) A relevant grade which is regarded as equivalent of 55% wherever the grading system is followed by a recognized university, at the Mater's level shall also be considered valid.

#### **INSTRUCTIONS TO CANDIDATES**

- 1. The payment made through online mode will not be accepted.
- 3. The Application will be accepted upto 4<sup>th</sup> November, 2023 before 5.00 pm. The applications received after will not be entertained.

- 5. Knowledge of Marathi is essential.
- 6. Candidate has to ensure that, he / she is eligible in all respect as per the eligibility conditions.
